- It is noted that the section "Distinguishing positive action and positive discrimination" has been removed from the Code. We consider that this was a useful section and addresses a common question in this area. We suggest that it is included in the current Code.
- Paragraph 10.3 we suggest that in the sentence "Organisations in both the
  public and private sector often want to take action to address these
  disparities and improve their services and engagement with particular
  groups within the community" should be amended to include reference to
  third or voluntary sector organisations.
